This Agreement is renewable at the option of the Subscriber so long as premiums are paid in a timely manner, the Subscriber has not performed an act or practice that constitutes fraud and VSP continues to offer this Agreement. VSP will send a renewal notification to Subscriber at least thirty (30) days prior to the expiration of this Agreement.

## DEFINITIONS OF WORDS AND PHRASES USED IN THIS AGREEMENT

<b>Member</b>	A person covered under this Agreement, including the Subscriber and any other covered person.
<b>Services and Materials</b>	The vision care services and vision care materials which a Member is entitled to receive by virtue of coverage under this Agreement.
<b>Term</b>	A twelve (12) month period beginning on the date of purchase of this Agreement.
<b>Agreement</b>	This document and all of its attachments, if any.
<b>Subscriber</b>	The person who signed the application for this Agreement and who is responsible for payment of fees for the Services and Materials covered by this Agreement.
<b>You, Your</b>	The person covered under this Programme. The Subscriber or Member.
<b>VSP Programme Provider</b>	An Optical 88 optometrist or ophthalmologist, licensed and otherwise qualified to provide vision care services and/or provide vision care materials, who has contracted with VSP to provide Services and Materials on behalf of Members of VSP.
<b>We, Us, Our, VSP</b>	This refers to VSP Vision Care.

## SERVICES AND MATERIALS

During each Term the following vision care services and/or materials are available to Member under this Agreement, and when purchased by Subscriber.

### EXAM PROGRAMME – COVERED- IN- FULL

Each Term, Members are entitled to receive one comprehensive eye exam which focuses on eyes and overall wellness. This Agreement also includes a comprehensive eye exam full written report, or summary of optometrist's clinical findings and observations from the exam as well as a retinal photo. The report is covered- in- full and provided upon request by Subscriber or Member. There is an approximate 1-week processing time.

### Additional Savings and Discounts

In addition to the specific Services and Materials stated above Member will receive a discount of twenty percent (20%) off the retail amount of a complete pair of prescription glasses, including lens options. Members are entitled to receive a discount of ten percent (10%) off the retail cost of contact lens materials when purchasing contact lenses. Each Term, Members are entitled to a covered-in-full annual contact lens fitting, and evaluation, when contact lenses are purchased. If contact lenses are not purchased, Member will pay HK\$150.

## EXAM PLUS PROGRAMME – COVERED-IN-FULL

If You purchased the Exam Plus Programme, You will receive one (1) comprehensive eye exam **or** (1) refraction eye exam which focuses on visual acuity each Term. The Exam Plus Programme also includes a frame and lens package **or** contact lenses every 12 months based on Term date, inclusive of all applicable taxes.

### Frame and Lens Options

If you purchased the Exam Plus Programme you will be entitled to a single vision lens option\*\* or a progressive lens option\*\*. The single vision option includes a fully covered lens option (anti-reflective and EMI shielding included) or an allowance up to HK\$640 toward any lens of your choice, plus a 20% discount on the amount exceeding the allowance. The progressive lens option includes a fully covered lens option (anti-reflective and easy-to-clean coatings included) or an allowance up to HK \$1200 toward any lens of your choice plus a 20% discount on the amount exceeding the allowance. \*\*House brand lenses with an index of 1.5 are generally covered under the plan, while higher indexes are subject to top-off.

If you purchased the Exam Plus Programme and you choose the frame and lens option you will be entitled to a frame allowance of HK\$1100. The Member can choose from a collection of designer eyewear with no out-of-pocket cost. The Member will also receive an additional savings of 20% on the amount exceeding the allowance.

If you purchased the Exam Plus Programme and you choose the contact lens option you will be entitled to HK\$900 per year towards contact lenses (**instead of eyewear – frames and lenses**). The Member will receive a 10% discount on the amount exceeding the allowance. With regard to the contact lens exam, the fitting and evaluation will be covered-in-full when contact lenses are purchased. If contact lenses are not purchased, the Member will pay HK\$150. Contact Lens must be purchased through the VSP Programme Provider.

## HOW TO OBTAIN SERVICES AND MATERIALS UNDER THIS PLAN

To receive Services and Materials, Member will contact a VSP Programme Provider at an Optical 88 Professional Eye Care Centre and make an appointment. Identify Yourself as a VSP Member and the VSP Programme Provider will contact VSP to verify Your eligibility. If a Member utilizes a provider who is not a VSP Programme Provider, payment for all Services and Materials will be the responsibility of Member.
